Price quoted by the bidder should be inclusive of all taxes, sampling charges, other incidental charges and F.O.R The Bhagirathi Cooperative Milk Producers' Union Limited and in adherence to the payment terms and other general terms and conditions enshrined in this NIQ. No escalation in price will be considered after submission of bids.
- 4. The bidders participating in the quotation must provide the following Mandatory Documents along with the price bids:
