- 5. Jobs must be completed within 20 days after placement of Work Order.
- 6. Payment shall be made in NEFT/RTGS after 30 days of receipt of the bill along with the submission of work completion Certificate duly certified by Competent Authority.
- 7. In case there is any discrepancy in quality the Milk Union may impose a penalty and then accept the goods. In this case prior intimation shall be given to the supplier.
- 8. In case of any dispute between the Milk Union and the bidder the decision of the Milk Union shall be final and binding.
