2. Quotation shall only be accepted in sealed envelope subscribing the Enquiry No. and Item Type. No quotations shall be accepted through mail. Incomplete quotations are liable to be rejected.
3. Price quoted by the bidder should be inclusive of all taxes and levies in adherence to the payment terms and other general terms and conditions enshrined in this NIQ. No escalation in price will be considered after submission of bids.

4. The bidders participating in the quotation must provide the following Mandatory Documents along with the price bids:
- Copy of NIQ duly signed and Sealed as a token of acceptance of all terms and conditions in the NIQ.**
 - GST Registration Certificate**
 - Rate must be quoted by the bidder as per the table given above**
 - Authorization Certificate from Principal Company (Canon).**

Failure to submit the above mandatory documents shall lead to rejection of the Quotation.

5. Materials must be delivered within 7 days after placement of Supply Order.
6. 1year Comprehensive Onsite Warranty from the Principal Company.
7. Specifications of the Printer (Canon LBP6030B) as provided by the Principal Company.
8. Payment shall be made in NEFT/RTGS after 30 days of receipt of the bill along with warranty documents, operation manuals and the materials in good condition certified by Competent Authority.
9. The material received if found to be containing manufacturing defect shall be rejected upon mutual inspection.
10. In case there is any discrepancy in quality, the Milk Union may impose a penalty and then accept the goods. In this case prior intimation shall be given to the supplier.
11. In case of any dispute between the Milk Union and the bidder the decision of the Milk Union shall be final and binding.
12. The Milk Union reserves full right to accept or reject any quotation/all quotations or to cancel the entire process without assigning any reason thereof.
