### Payment procedure

- a) Payment by Net Banking (any listed bank) through IClCI Bank Payment Gateway:
- 1. On selection of net banking as the payment mode, the bidder will be directed to IClCI BankPayment Gateway webpage (along with a string containing a Unique ID) where he will select theBank through which he wants to do the transaction.
- 2. Bidder will make the payment after entering his Unique ID and password of the bank to processthe transaction.
- 3. Bidder will receive a confirmation message regarding success/failure of the transaction.
- 1. If the transaction is successful, the amount paid by the bidder will get credited in the respectivePooling account of The Bhagirathi Cooperative Milk Producers' Union Limitedmaintained with the Focal Point Branch of IClCI Bank at R.N. Mukherjee Road, Kolkata forcollection of EMD/Tender Fees.
- 2. For transaction failure, the bidder will again try for payment by going back to the first step.

#### b) Payment through RTGS/NEFT:

- 1. On selection of RTGS/NEFT as the payment mode, the e-Procurement portal will show a pre-filledchallan having the details to process RTGS/NEFT transaction.
- 2. The bidder will print the challan and use the pre-filled information to make RTGS/NEFT paymentusing his Bank account.
- 3. Once payment is made, the bidder Will come back to the e-Procurement portal after expiry of areasonable time to enable the NEFT/RTGS process to complete, in order to verify the paymentmade and continue the bidding process.
- 4. If verification is successful, the fund will get credited to the respective Pooling account of The Bhagirathi Cooperative Milk Producers' Union Limited maintained with the Focal Point Branch of ICICI Bank at R.N. Mukherjee Road for collection of EMD/Tender Fees.
- 3. Hereafter, the bidder will go to e-Procurement portal for submission of his bid.
- 4. But if the payment verification is unsuccessful, the amount will be returned to the bidder's account.

#### **B. Refund/Settlement Process:**

- i. After opening of the bids and technical evaluation of the same by the Quotation inviting authoritythrough electronic processing in the e-Procurement portal of the State Government, the Quotationinviting authority will declare the status of the bids as successful or unsuccessful which will bemade available, along with the details of the unsuccessful bidders, to IClCI Bank by the e-Procurement portal through web services.
- ii. On receipt of the information from the e-Procurement portal, the Bank will refund, through anautomated process, the EMD of the bidders disqualified at the technical evaluation to therespective bidders' bank accounts from which they made the payment transaction. Such refundwill take place within T+2 Bank Working Days where T will mean the date on which informationon rejection of bid is uploaded to the e-Procurement portal by the Tender inviting authority.
- iii. Once the financial bid evaluation is electronically processed in the e Procurement portal, EMD of the technically qualified bidders other than

	that of the L1 will be refunded, throughan automated process, to the respective bidders' bank accounts from which they made thepayment transaction. Such refund will take place within T+2 Bank Working Days where T willmean the date on which information on rejection of financial bid is uploaded to the e-Procurementportal by the Quotation inviting authority.
	iv. If the L1 bidder accepts the LOI and the same is processed electronically in the e-Procurementportal and the information on Award of Contract (AOC) tothe L1 bidder is uploaded to the e-Procurement portal by the tender inviting authority.

## **General Terms & Conditions**

- 1. During evaluation the Milk Union may summon any bidder and seek clarification/information regarding bids within the stipulated time frame. In case the bidders fail to clarify any query during the stipulated time frame the bid shall be liable for rejection.
- 2. The Milk Union may reject any bid from any party with unsatisfactory performance with the Milk Union or any other Milk Union in the past.
- 3. Inspection of materials may be undertaken at the supplier's premises whenever necessary by the Tendering Authority/ any officer authorized by the undersigned.
- 4. Bidders are required to go through the Tender Documents understand the requirement and then quote their rate. Rate once quoted by the bidder shall be deemed to be quoted by the bidder after understanding the requirements of the Milk Union. Rates once quoted are final and no alteration in rate shall be allowed.
- 5. **Price:** Price to be quoted as per BOQ. Price to be quoted must be inclusive of all taxes and levies, transit insurance and any other incidental charges FOR Bhagirathi Milk Union.
- 6. Payment shall be made within 30 days in NEFT/RTGS on receipt of quality report of the supplied materials from Requisitioning Authority & on submission of Bill in duplicate along with the received challans from the Competent Authority. If the materials received does not conform to the above prescribed standard then the materials shall not be accepted or rejected after joint inspection.
- 7. **EMD & Security Deposit**: EMD shall not carry interest. EMD of the successful bidders shall be converted into Security Deposit and shall be released along with the first phase of payment. EMD of disqualified bidders shall be refunded as per norms.
- 8. **Insurance:** The supplier shall make arrangements for insuring the goods against loss or damage incidental to manufacture or acquisition, transportation, storage, and delivery. If the components are not handed over to The Bhagirathi Co-operative Milk Producers Union Ltd. within the specified period, the insurance will have to be extended by the supplier at their cost till the successful handing over of the goods to The Bhagirathi Co-operative Milk Producers' Union Ltd.
- 9. **Penal Measure**: Time being the essence of the contract, failure to supply the materials within due time shall invite penalty. For violation of any terms and conditions of the contract the Bhagirathi Milk Union reserves the right to cancel the contract without assigning any reason thereof. On termination of Contract the Security Deposit will be forfeited and the resultant loss shall be recovered from the company. The subsequent company will be blacklisted for 3 years.
- 10. **Loading and Unloading** of goods is the responsibility of the supplier. If the Milk Union makes its own arrangement for the unloading of the materials the respective cost of the same shall be deducted from the bidder.
- 11. **Documentation**: Complete documentation like principal warranty papers, manuals, document of technical specifications and guarantee cards have to be furnished by the supplier. Failure to submit

any of the above documents in hard copies at the time of supply of the materials shall lead to non-acceptance of the material.

- 12. **Inspection**: The Milk Union shall make a detailed inspection of all components prior to the acceptance of the material. The Milk Union can also conduct joint inspection or engage a third party for inspection of the components.
- 13. **Warranty**: The bidder must provide 3 years of comprehensive onsite warranty against each item. Materials delivered if found to be possessing manufacturing defect must be replaced by the supplier within 7 days with new item failure to which shall attract penalty and forfeiture of Security Deposit. The subsequent company shall also be blacklisted from participation into any tender for 3 years.
- **14. Service Centre:** Bidder must have a service centre in the WB region. Proof like electricity bill, municipal tax receipt etc., must be provided.
- 15. **Delivery**: The materials must be delivered in the Office of The Bhagirathi Cooperative Milk Producers' Union Ltd. Feeder Dairy, Panchantala, Berhampore, Murshidabad, Pin-742101, West Bengal.
- 16. **Standards:** The Goods supplied under this Agreement shall conform to the standards mentioned in the Technical Specifications and when no applicable standard is mentioned, to the authoritative standards appropriate to the Goods' country of origin.
- 17. **Registration of Goods:** If required under the Applicable Law, Goods supplied under the Agreement shall be registered for use in India.
- 18. **Packing:** The Supplier shall provide such packing of the Goods as is required to prevent their damage or deterioration during transit to their destination, as indicated in the Purchase Order. Damaged goods shall not be accepted.
- 19. **Dispute Resolution** Any dispute arising out of the Agreement, which cannot be amicably settled between the parties, shall be referred to adjudication/arbitration in accordance with the Arbitration and Conciliation Act of 1996 of India. The venue of adjudication/arbitration shall be Kolkata. The language of arbitration shall be English.
- 20. **Applicable Law:** The Agreement shall be interpreted in accordance with the laws of Union of India.
- 21. **Force Majeure:** If, at any time during the subsistence of this contract, the performance in whole or in part by either party of any obligation under this contract is prevented or delayed by reasons of any war or hostility, act of public enemy, civil commotion, sabotage, fire, floods, explosion, epidemics, quarantine restriction, strikers lockout or Act of God (hereinafter referred to as events) neither party shall have any claim for damages against other in respect of such non-performance or delay in performance.
- 22. The undersigned reserves the right to accept or reject any tenders and to cancel the entire tender process without assigning any reason whatsoever.
