Scope of Service:

- 1) Fabrication of 2" ammonia condenser coils of 21' length and 400' length in two rows with inner connection through 3" sub header & 4" gas header and 2½" liquid sub header & 3" liquid header.
- 2) Fabrication of 21 feet perforated water spray headers on 2 nos of new coils along with inters connection to the existing water header.
- 3) Fabrication of air purging tube with necessary valve on 4" dia gas header.
- 4) Modification of liquid ammonia line from liquid header to facilitate gravity flow of liquid ammonia to the ammonia receiver.

Both the sealed covers of Technical and Financial bid shall be placed in another bigger sealed cover having written on its top as "BID for **NIT for Augmentation of Refrigeration capacity at KCP**".

The bid shall be submitted in The Bhagirathi Cooperative Milk Producers' Union Limited., Feeder Dairy, Panchanantala, Berhampore, Murshidabad, 742101.

Validity of the bid: The bid once submitted will be valid for 60 days.

Work Completion Period: The selected bidder shall be completed the work within 10 days from the date of issuing work cum supply Order.

Other Terms & Conditions:

- 1. The bidders are required to submit their tender before last date and time of submission. No bids will be accepted for evaluation after last date and time of bid submission.
- 2. Partial/incomplete tenders are liable to be rejected. The tender documents should be properly indexed and signed and sealed by the bidder.
- 3. Price quoted by the bidder should be inclusive of all taxes levies packing, forwarding and transportation charges & FOR Kandi Chilling Plant, Kandi.
- 4. Time being the essence of contact, the job must be completed within 10 days after placement of Work Cum Supply Order.
- 5. Penal Clause: Liquidated Damage of 0.5% of the total cost shall be charged if there is any delay in completion of the Job subjected to a maximum of 10% of the total cost and the amount shall be recovered from the bills.
- 6. Force Majeure: For delay in supply of goods for which neither the supplier or the Milk Union is responsible like strikes, lockouts, war, catastrophe shall be termed as "Force Majeure" and penalty clause will not be applicable.
- 7. Payment will be made in NEFT/RTGS after 30 days after satisfactory completion of the job certified by competent authority.
- 8. If the materials received is found faulty or possess any manufacturing defect as a result of poor workmanship within a month or two then it has to be replaced by the party.
- 9. In case of any dispute between the Milk Union and the bidder the decision of the Milk Union shall be binding.

The Managing Director of The Bhagirathi Cooperative Milk Producers' Union Limited reserves the right to reject or cancel any bid without assigning any reason whatsoever.
