The Bhagirathi Cooperative Milk Producers' Union Limited (hereinafter called "the Milk Union") invites Expression of Interest (hereinafter called "EoI") in two cover system (Technical & Financial) from veterinary professionals/ veterinary service providers for implementing **two units of ON CALL VETERINARY SERVICE** within the district of Murshidabad initially for a period of one year w.e.f 1st January, 2023 which may be extended further if the Milk Union so desires subject to satisfactory performance of the service provider.

#### INTRODUCTION ABOUT THE MILK UNION:

The Bhagirathi Cooperative Milk Producers' Union Ltd., was established in the year 1974, under the "Operation Flood Programme" as a Cooperative Society and is registered under West Bengal Cooperative Societies Act and Rules. The main objective of Bhagirathi Milk Union is bringing about socio-economic transformation of the rural masses through organizing Dairy Cooperative Societies in the district of Murshidabad. Over a period of 49 years, the Bhagirathi Milk Union has been able to infuse a new life in the cooperative movement of the West Bengal, ensuring democratic functioning of the cooperatives such as members' involvement in decision making process, to promote thrift, self-help and mutual aid, involving womenfolk and also to provide for transparent, devoted and efficient management and services relevant to the needs of the cooperatives. The operational area of the Union is entire Murshidabad district which covers 26 blocks.

#### **SCOPE OF WORK:**

- 1. The service provider will ensure the service at the door step of the concerned farmers for treatment of sick / injured animal as per the call/direction of the Bhagirathi Milk Union without any delay and provide follow up treatment of sick/injured animals which he/she attended.
- 2. Service providers will attend each calls from the Milk Union and ensure his/her visit for diagnosis, provide medicines in the spot, make prescription properly, maintaining farmers' name, address & contact no. etc. well in the register for feed back to the Milk Union. On the other hand Milk Union shall also maintain registers of such record accordingly.
- 3. He/ she will maintain a stock register exclusively for medicines received from the Milk Union and provided to the farmers concerned.
- 4. No vehicle/TA/DA or other amount shall be provided from the Milk Union except the professional fees. Transportation shall be arranged in his/ her own cost. Milk Union will not provide/support any manpower on account of such services.
- 5. After the rendering the satisfactory services at the door of the farmers he/she will recover an amount of **Rs.150/-** from the farmer concerned as treatment fees through issuing the prescribed Money Receipt. Some fundamental medicines, surgical equipments, Prescription Pad, Money Receipt & Registers shall be provided by the Milk Union.
- 6. He/she shall not be entitled to get any amount beyond **Rs.150/-** from the farmers on account of cost of medicines/surgery etc.
- **7.** Rude behavior, consumption of liquor, smoking, chewing pan/Gutkha etc. and items under NDPS Acts are strictly prohibited during visit at the door step of the farmers. Non-Compliance may lead to suitable penalty or termination of contract.
- 8. At least one month prior notice is required to quit from rendering such services failing which administrative action shall be taken accordingly.

### **SELECTION PROCESS:**

Rate of monthly professional fees is to be quoted in the Financial bid in the prescribed format (ANNEXURE-2) separately subject to maximum amount of **Rs.40000/-** per month. However, beyond such rate if quoted shall lead to be disqualified. Only the quoted rate within Rs.40000/- per month shall be acceptable for bid comparison. Lowest bidder amongst the technically qualified bidders shall be selected for issuance of award of contract subject to the approval of the competent authority of the Milk Union.

#### **PAYMENT OF PROFESSIONAL FEES:**

1. On rendering the satisfactory services both the service providers will be entitled to get a **maximum amount of professional fees of Rs. 40000/-** (excluding GST) per month or the quoted rate whichever is less, shall be considered for payment for each unit subject to performing at least 200 visits at the door of the farmers with satisfactory service. Such fees may be decreased proportionately in case of less than 200 visits.

- 2. In addition to the above visiting fees with a maximum amount of Rs.150/- per visit shall be realized from the respective farmers by the medical practitioners through issuing proper money receipts provided by the Milk Union in a prescribed format on account of such services.
- 3. Monthly bills of the service providers are required to be submitted within 10<sup>th</sup> of the next month along with all the Money Receipts & Duplicate copies of prescription. TDS shall be deducted from the bills as per the provision of I.T Act.
- **4.** The service providers will at no point of time be the employees of the Bhagirathi Milk Union and there will be no relationship of employer and employees between the Bhagirathi Milk Union and the service providers.
- 5. The Milk Union reserves the right to termination of the contract at any time during the contract period.
