TERMS & CONDITIONS FOR HIRING OF RAW MILK CHILLING & PROCESSING

- 1. The plant must have all the arrangements (including plant/equipment/machinery/manpower for raw milk reception, can washing, milk chilling at desired temperature, storage, pasteurization as per requirement and loading into milk tankers as per schedule.
- 2. The Capacity for raw milk reception and processing should not be less than 5000 litres per hour (lph).
- 3. Arrangement of laboratory milk reception point with furniture, lights, fans proper cleaning and drinking water availability should be there.
- 4. Raw milk shall be sent to plant in morning and evening shifts from 9 am to 11 am and 9 pm to 11 pm respectively for which proper accounts shall be maintained by both ends. While accounting for recovery of FAT & SNF, BHAGIRATHI would allow actual processing loss of FAT/SNF while handling milk subject to maximum limit of 1% Total Solids, on total quantity of milk received on fortnightly basis along with bill towards raw milk chilling and processing. Any other loss beyond the limit during reception/handling, storage and processing of milk over and above the prescribed limit would be your personal responsibility and on account of bidders plant.
- Bidder shall maintain FSSAI regulations and its provisions related their under, for ensuring good manufacturing practice, plant hygiene and house-keeping, as applicable.
- Packaging station has to custom pack and deliver the agreed quantity and varieties of milk to its representatives from time to time and shall be responsible and liable to strictly comply with the provisions / requirements of the Prevention of Food Adulteration Act, 1954 / FSSAI and the rules framed there under as applicable from time to time being processors and packers of Bhagirathi Milk.
- 7 The minimum MBRT (Methylene Blue Reduction Test) time for pasteurized milk delivered should be 6.00 hours. SPC (Standard Plate Count) should be less than 30,000 per ml, coliform should be nil,

- 8 Phosphatase Test should be negative and temperature of processed milk delivered is not more than 5°C in milk tankers.
 - 9. Bidder shall be responsible and liable to ensure that the requirements relating to weighing accuracy of raw milk received in accordance with the provisions/requirements of the Standard Weight & Measures Act, 197 and the Rules framed there under time to time or any other Act &Rules as applicable from time to time.
 - 10. Offered plant should have standard CIP system, effluent disposal system to ensure compliance of Pollution Control Norms and hygienic environment as per norms complying FSSAI Standards.
 - 11. Bidder shall engage/depute only qualified and trained technical staff for processing of Milk so as to ensure the proper quality norms etc., as per PFA/FSSAI and Weight & Measures Act and also nominate one of his persons as nominee under the provisions of PFA/FSSAI.
 - 12. Packaging Station will also ensure that office space and laboratory facilities for testing of milk are adequate to the satisfaction of our technical person(s). Laboratory equipment and testing material would be provided by packaging station free of cost. The testing methods & equipment will be adopted as per the BIS standards for testing of milk, etc.
 - 13. Adequate arrangement and space should be there for loading and unloading of Road Milk Tankers of 20000 Lt Capacity and for Despatch vehicles at the Plant.
 - 14. Packaging station shall give us an irrevocable Bank guarantee of Rs.10 lacs (Rupees Ten Lacs only) from Nationalized Bank in India valid for 24 months to begin with as security towards the cost of the milk and for performance. This is required to cover BHAGIRATHI any loss or damage to the milk/items, while in custody of packaging station.
 - 15 Bidder shall keep all its machinery and fixtures in proper working conditions at all times so that the regular and uninterrupted service.

- 16 If there is any statutory tax deduction at source or otherwise on charges/amount payable to packaging station that will be deducted as per statutory rates, applicable from time to time.
- 17 This arrangement shall be initially be applicable for the period of three months from the date of signing of the agreement, which can be further extended for a mutually agreed upon period of time on the settled terms and conditions, a formal meeting would be held with the party by the committee members of BHAGIRATHI for negotiating the rates and other terms and conditions for the next agreement. However, both the parties shall be at liberty to terminate the chilling and processing arrangement by giving 45-day notice in advance by either side.
- 18 In case of any dispute or difference shall at any time arise between the two parties (i.e. BHAGIRATHI& Packaging Station) in respect of or concerning anything herein contained or arising out of above arrangements or as to the rights liabilities or duties of the said parties hereunder or as to the recovery of any amount, the same shall be referred to the sole arbitration of the Managing Director, BHAGIRATHI, Murshidabad. The decision of the Arbitrator shall be final and binding upon both the parties. Jurisdiction for this agreement would vest with the Courts situated at Murshidabad only.
