2. Quotation shall only be accepted in sealed envelope subscribing the Enquiry No. and Item Type. No quotations shall be accepted through mail. Incomplete quotations are liable to be rejected.
3. Price quoted by the bidder should be inclusive of all taxes, sampling charges, other incidental charges and F.O.R The Bhagirathi Cooperative Milk Producers' Union Limited and in adherence to the payment terms and other general terms and conditions enshrined in this NIQ. No escalation in price will be considered after submission of bids.
4. The bidders participating in the quotation must provide the following Mandatory Documents along with the price bids:
 - a. **Copy of NIQ duly signed and Sealed as a token of acceptance of all terms and conditions in the NIQ.**
 - b. **GST Registration Certificate**
 - c. **Rate as per format in FORMAT – A.**
