Tentative Delivery/Supply Schedule: Within 20 Days of placement of purchase order.

General Terms and Condition:

- Rate to be quoted by the Bidder:** Rate should be Quoted by the bidder shall be inclusive of all Taxes and Levies, GST other charges/ taxes if any for the delivery of the goods in the office of the Bhagirathi Cooperative Milk Producers' Union Ltd.
- Delivery of goods:** In consignments of 6,00,000 pieces for 80.5 mm foil and 2,00,000 pieces for 96 mm foil. PO shall be raised accordingly. Quality of printed samples shall be verified prior to placement of PO.
- Place of Delivery:** The Bhagirathi Cooperative Milk Producers' Union Limited (BCMPUL) Feeder Dairy, Panchanantala, Berhampore, Murshidabad, W.B. 742102.
- Price Escalation:** The price should quoted fixed and shall not be subjected to any escalation.
- Certificate:** Supplier should certify that the material supplied is of food grade, non-toxic and conforms to the FSSAI standard.
- Packing:** Supplier shall provide such packing of the goods as is required to prevent from any kind of damage or deterioration during transit and storage.
- Terms of Payment:** Payment will be made in NEFT/RTGS within 45 days after delivery of the goods and receipt at the store of the Milk Union section in a good condition followed by submission of 3 copies Invoice and certificate of analysis. The Bank Detail of the supplier are to be clearly mentioned in the bills.

8. **Penal Provision:** Penalty shall be imposed if there the material supplied does not conform to the specifications, quality or quantity and the cost will be deducted from the bill accordingly. If material is found to be substandard or deviates from size sealing property, colour etc. the material shall be rejected outright. Rejected material has to be lifted within 45 days else the Milk Union shall reserve the right to dispose them.
9. **Liquidated Damage:** Liquidated Damage of 0.5% of the total cost of the Order shall be charged if any delay in supply of goods subjected to a maximum 10% of the total cost of the Order and amount shall be recovered from the bills of the supplier. If the Milk Union makes alternative arrangement to procure goods due to delay in supply by the supplier the cost of the consignment form arranged for different source shall be deducted from the party.
10. **Force Majeure:** For delay in supply of goods for which neither the supplier or the Milk Union is responsible like strikes, lockouts, war, catastrophe shall be termed as “Force Majeure” and penalty clause will not be applicable.
11. **Dispatch:** Mode of transportation, transit insurance for the supply of the goods to BCMPUL will be arranged by the supplier. Materials dispatched from the bidder until or unless reaches the BCMPUL is the sole responsibility of the bidder. The Milk Union will not be responsible for any damage in transit and no claim in this regard will be entertained.
12. **Unloading of goods:** Unloading of the goods shall be done by the Milk Union. Unloading shall be done within office hour (10:00 am to 06:00 pm). Suppliers are required to plan dispatch accordingly.
13. **Dispute Settlement:** In Case of any dispute between the Supplier and Milk Union, decision of the Milk Union shall be the final and binding.
14. **Other Terms and Condition are as per stranded Terms and condition of the NCDFI.**
