GENERAL TERMS AND CONDITIONS

- 1. Installation of proper temperature & tracking system with fastag facility is mandatory. Toll tax and levies (except over loading charges) shall be reimbursed by the Milk Union on actual basis subject to submission of toll tax statement / original receipt along with the bill.
- 2. In case, Milk union provides extra load (more than scheduled crates) then bill will be paid for extra load on proportionate basis and over loading charges / penalty (if any) will be paid by the milk union subject to submission of original fine receipt along with the monthly bill.
- 3. Per k.m rate including all cost shall / will be increased or decreased proportionately depending upon the monthly average fuel price of the respective every month.
- 4. The Bhagirathi Co-operative Milk Producers' Union Ltd. will not accept any variation in conditions stipulated in the tender. Any suggestion in the tender, for any modification of the tender conditions will not be entertained and the conditional offer will render the tender invalid.
- 5. The proposed vehicle which will be provided for transportation of milk and milk products should be in good condition. Preference will be given to new vehicles.
- 6. The transport vehicle staff shall also be responsible for collecting cheques/drafts/letters/Crates, Boxes and other related materials from distributors and submitting it to the official of the concerned Department.
- 7. Refrigerated vehicles should be maintained a continual temperature (+) 2 ° C 4 ° C during transit. The vehicle must strictly comply insulation / refigeration norms. For any kind of damages to the vehicle or all kind of repairing charges are to be borne by the transporter. In case of breakdown of schedule vehicles, transporters are bound to arrange alternative vehicles of same capacity and same categories, for uninterrupted supply of milk & milk products. In default transporters are liable to compensate to milk union an amount not less than extra expenditure/ loss incurred/ suffer by the Milk Union in arranging alternative vehicles/ reprocessing of milk.
- 8. If the tenderer has already been blacklisted by any Government/ Government Undertakings/ Co-operative societies, his tender will be rejected. In case information about such black listing comes to the knowledge of the Union after awarding of the tender, the contract will be terminated, liquidated damages levied, apart from taking penal action.
- 9. BCMPUL reserves the right to accept or reject any or all tender wholly / partly without assigning any reason thereof at any time.
- 10. Successful bidder has to provide vehicle within admissible date and time as decided / mentioned by the milk union.
- 11. Vehicles will be run as per scheduled timetable of the Milk Union. The Managing Director of the Union reserves the right to add, subtract and modify any terms and conditions of the agreement with the consent of the Contractor during the contract period.

Precautions:

- 1. <u>The tenderer must satisfy himself thoroughly about the geographical area to be covered, nature of work, route conditions /local conditions and the requirement of the Milk Union before submitting his tender.</u>
- 2. The person signing the tender should be the Proprietor / Partner / Managing Director or any other person duly authorized to sign the tender document, etc. In the latter case, authorization letter should be attached.
- 3. The tenderer should read every page and understand the implications fully and offer the tender only if he could discharge the obligations set out in the tender documents.
- 4. Required specification for Insulation or Refrigerated vehicles is attached along-with.
- 5. The tenderer can visit our office where the clarifications sought for by the tenderer will be given.

Other terms & Conditions

- 1. The Transporter of the scheduled routes will be liable to carry out and hand over the milk and milk products to the said distributor / retailer (as planed or according to challan). The contract will be valid for 3 years from the date of acceptance of the Work Order / placement of vehicles and the Transporter will be liable for providing the service for that stipulated time period only. May be extended further, if required, on mutual consent.
- 2. Refrigerated vehicles should be insulated properly to maintain a continual temperature of 2^oC to 4^oC. The vehicle must strictly comply with insulation and refrigeration norms.
- **3.** If the service of the transporter is not found satisfactory or it is adverse to the interest of the Milk Union then the Milk Union may terminate the contract at any point of time, without assigning any reason. On termination of the contract the Security Deposit and EMD shall be forfeited and the transporter shall be blacklisted and no claim in this regard shall be entertained.
- 4. The Transporter will be liable to receive the milk and milk products from Feeder Dairy according to the challan and time table, provided by the Marketing Section and transport them through refrigerated container vehicles to the distributor/retailer lying in the concerned route. Accordingly the transporter is bound to return the empty crates, boxes, drafts, received copy of challan and other documents to the Milk Union as soon as the vehicle returns to dairy. If the transporter fails to fulfill the aforesaid responsibilities due to any reasons, which causes any economic loss or detrimental to the reputation of Milk Union then the transporter will be compelled to compensate the penalty amount imposed by the Milk Union which will be deducted from the monthly bill of the transporter.
- 5. As per the instruction of the Milk Union, the transporter has to maintain a proper record regarding the list of items returned by the distributors/retailers. The transporter will be responsible for any damage of good or products during transit consignment or return of milk & milk products due to late arrival at the delivery end etc. which is caused by the transporter to the distributers/retailers due any sort of mistakes/ negligence. In such situation, the Milk Union will have the power to compensate the loss by deducting suitable amount from the bills of the transporter due to the negligence of the transporter. The decision of the Milk Union will be final and binding on the transporter.
- 6. If the Bhagirathi Milk Union has shorten/ reduce the route or forced to stop the supply of the milk and milk products of any distributor/retailer of the said route due to any reasons, the Bhagirathi Milk Union will not be bound to pay any compensation to the transporter. The transporter is bound to follow the instruction of the Union on this note. Bhagirathi Milk Union will inform the decision to the transporter before 7 days in advance.
- 7. If the engaged vehicle of the transporter is unable to supply milk and milk products due to break down or any others reason whatsoever then the transporter has to arrange an alternative vehicle immediately to continue the transport service. If he fails to do so, he will be liable to pay the amount of extra expenditure incurred by the Milk Union in arranging such alternate vehicle along with penalty as fixed by the milk union. Engagement letter / contract may be cancelled / terminated without assigning any reason. The corresponding amount along with penalty, if any, will be deducted from the bill of the transporter.
- **8.** As transportation of milk and milk products belong to emergency service, the transporter will have to affix a board written "ON EMERGENCY MILK DUTY BHAGIRATHI MILK UNION" on the vehicle, such that it draws the attention of everyone and the transport service does not get interrupted.
- **9.** The transporter shall have to maintain one reserved space in the transporting vehicle for one of the official of the Milk Union and in case of any accident, the rules of Motor Vehicles (MV) Act will be followed. Income Tax Act, Insurance Act etc. also applicable upon the transporter.
- 10. During the transit the transporter shall not carry any passenger or any other materials without permission of Milk Union. If the transporter or his/her staff is to do so and associated with any illegal activities or any accidents took placed, Milk Union will not be responsible morally/legally regarding the aforesaid matters. In this case the transporter or owner of the vehicle is only be responsible to compensate & comply the legal obligation to the victims or dependants of the victims etc as per law of the country enforce time to time.

- 11. That the transporter shall have to deposit a refundable interest free Security Deposit of Rs. 100,000/- for each vehicle in favour of The Bhagirathi Cooperative Milk Producers' Union Ltd.in Demand Draft in any Nationalized Bank payable at Berhampore at the time of acceptance of work order, in default said amount will be deducted from the transport bill in 4 (four) installments. Security Deposit interest free will be released after 6 months of successful execution of the contract.
- 12. Temperature monitoring & GPS Tracker installation is mandatory and shall be on during trip.
- **13.** The Milk Union may increase/decrease the number of distributors / retailers in the said route and the transporter will be bound supply the goods to the newly appointed distributors / retailers as per instruction of the Milk Union.
- 14. In case of increase in/decrease in the number of distributor / retailer, for which the total traversal may be increases / decreases, rate escalation/de-escalation shall not be given by the Milk Union to the transporter as per prevailing market rate. Rate escalation on any other account shall also not be entertained during the entire contract period.
- **15.** The transporter has to submit the transport bill (triplicate) within 7th day of next month. Bill amount will be paid to the transporter within 30 days thereafter. In case of failure to submit the bill within 7th day of succeeding month, the Union will not be responsible for any delay in paying monthly bill. Income tax Act and rules, service tax, GST Act. Etc. will be imposed / applicable accordingly.
- 16. The transporter will be fully liable or responsible for any demurrage of milk and milk products etc. due to negligence to arrange the alternative vehicle or any other negligence from the end of the transporter or his/her stuff. The reprocessing cost shall be minimum @Rs.5/-per crate of milk and demurrage / penalty amount as decided by the Bhagirathi Milk Union will be deducted or realized from the monthly transport bill of the transporter.
- 17. If required, the transporter will be liable to transport our milk and milk products to the other routes according to the challan and timetable as stipulated / provided by Marketing Section. During transit if any damage or accident occurs, the transporter or owner of the vehicle will be liable for that. For arranging the alternate vehicle approved rate of that route / type and capacity of the vehicle will be considered.
- **18.** The time table for placement of vehicle at dock area (FD), loading / receiving the milk and milk products and dispatch of our milk products to the distributors/ retailers of the said route, shall be finally decided by Marketing Section and communicated to you accordingly. The transporters are bound to follow the instruction / time table.
- **19.** No appeal for enhancement of rate will be entertained during the contract period. Due to any reason if the transport service is stopped or paused for a day / few days or for certain period by the transporter, then the transporter has to pay the total transportation cost for arrangement of alternative vehicle made by the Milk Union and suitable penalty & compensation will be imposed upon the transporter. Also liable to terminate the contract without assigning any reason thereon.
- **20.** The transporter will be liable to submit time to time all the necessary valid documents related to the vehicle such as legal permit, token, vehicle insurance, fitness certificate etc against the deployed / engaged vehicles to our office as when call for without fail.
- **21.** After accepting the contract, if the transporter fails to engage the vehicle according to the work order, his/her EMD, Security Deposit if any will be forfeited and he/she will not be able to participate in any kind of tender for three years.
- 22. If the transporter quits the job during the contract period, the demurrage cost as decided by the milk union will be collected from the transporter and the security deposit & EMD will also be forfeited and also a suitable penalty will be imposed.
- **23.** If any kind of doubt arises regarding the contract or its briefing, both parties can appeal to the arbitrator. In this case the arbitrator will be Chairman / Special Officer of the Milk Union or any representative nominated by them.

- 24. If it is found that transporter /any staff of the transporter is involved /engaged in any kind of illegal activities then legal action will be taken accordingly and if any transporter /staff of the transporter misbehaves with any officials of the union, then the particular staff / driver will have to be dismissed immediately.
- **25.** The transporter will not carry any other items/goods / persons other than the materials provided by the Milk Union. If so, a suitable fine will be imposed to the transporter without assigning any reason, for each time or vehicle engagement letter may be canceled / terminated without assigning any reason.
- **26.** If the dairy plant is required to be closed under any circumstances like shortage of power, strike, lock-out or any natural calamity and if the transportation service gets interrupted, the Union will not be liable to compensate any demurrage to the transporter.
- 27. This is completely a commercial contract, not for recruitment. No employee-employer relationship will be maintained between the transporter and the union. In addition to this the transporter has to follow the terms and conditions of the contract apart from this any instruction issued by the Milk Union will be followed by the Transporter without any objection.
- **28.** If the service of the transporter is found not satisfactory and violating any of the terms and conditions of the contract, the Milk Union reserves the right to terminate / cancel his/her contract & engagement letter at any time without assigning any notice or reason thereto.
- **29.** Due to any reason if the service of the transporter is no more required then Milk Union will not be liable to pay any kind of demurrage to the Transporter for the respective day or for the stipulated time period or for termination of the contract.
- **30.** The vehicle used by the transporters for transportation of our milk and milk products should comply with the terms of the M.V. Act, Insurance Act and all others relevant Acts which are applicable upon him in our Country enforced time to time. In case of any kind of fine / penalty imposed or any hit and run accident occurred or any kind of accident took place, then all the liabilities / penalty / obligation shall be lies upon and shall be borne by the transporter and owner of the said vehicle only.
- **31.** No unloading charges will be paid to the transporter. In addition to this, in case of sale enhancement of our milk and milk product, the transporter will have bound to engage an extra vehicle at the same rate or at the rate as decided by the Union.
- **32.** The transporter has to carry advertisement of Bhagirathi milk and milk products around the transporting vehicle provided by Milk Union.
- 33. The transporters of the <u>refrigerated vehicle have to maintain continuous temperature of our milk & milk products within 2°C- 4°C (degree) during transit</u>. In default penalty will imposed as decided by the Milk union for each day or days.
- **34.** If required to run the vehicle under insulated condition, then have to maintain within + 5 degree temperature from temperature received, during the transit / delivery point of our milk and milk products to the distributors in default penalty will imposed as decided by the Milk union.
- **35.** Deployed vehicles shall be covered with the Transit Insurance. The cost of that transit insurance shall be included within the quoted rate.
- **36.** Transporter must have to engage 1 helper along with driver for the engaged each vehicle. Bhagirathi Milk Union will not be responsible for compliance of any kind of legal obligation, statutory obligations for the staffs engaged by the transporter.
- **37.** Door of the engaged vehicles will remain locked with seal containing serial number during transit. If any damage / tampering/ variation are found upon enlisted seal without valid reason, suitable penalty will be imposed and deducted from transport bill.
- **38.** Considering the urgency / requirement of the milk union, refrigerated vehicles may be used in/ under insulated condition @ decreased rate of Rs.3/- per km from the existing rate of the individual vehicle proportionately. Any kinds of objection in this regard from the transporters are not accepted.

- **39.** One selection, the contractor has to execute an agreement on Non-Judicial Stamp paper of Rs.100/- which shall be supplied by the transporter.
- **40.** The transporter has to notify to the Milk Union before 3 months if he/she wants to withdraw the transport service. Failure to do so shall liable to pay the penalty as decided by the milk union along with forfeiture of Security Deposit and EMD. But, Bhagirathi Milk Union may terminate / cancel the contract / engagement letter by giving one (1) one month prior notice to the transporter at any time.
- **41.** If, required tenure may be extended further, subject to the satisfactory performance, depending upon mutual consent.
- **42.** The transporter shall responsible to collect and return the challan (duly filled and signed by the distributor or his representative) as a token of acceptance of the milk & milk products along with all returnable containers (like Crates, Box etc.) in good condition to the designated official of the Dairy. Any shortage, pilferage, theft, loose or damaged caused to/of the containers / crates / products during the process of transportation then loss amount shall be recovered from the Transporter. The amount of recovery will be:-
 - A) Consumer price in case of milk and milk products.
 - B) Cost price of Milk Crates and Insulated boxes.
 - C) Cost price of packing materials along with fine as decided by the Milk Union.
 - D) Reprocessing cost minimum @ 5/- per crate of the return milk due to negligence of the transporter.
