3. Price quoted by the bidder should be inclusive of all taxes, levies, forwarding and installation at The Bhagirathi Cooperation Milk Producers' Union Limited. No escalation in price will be considered after the bid submission.
4. The bidders participating in the quotation must provide the following Mandatory Documents along with the price bids:
 - GST Registration Certificate of the bidder.
 - Authorization Certificate: That the bidder is authorized to sell the product of the principal company.

8. **Tentative Delivery/Supply Schedule:** Materials must be delivered within 7 days after placement of Purchase Order.
9. **Warranty:** Laptop shall be warranty for the minimum period of 1 years from the principal Company with technical support and shall be warranty on-site for satisfactory performance, workmanship and for the quality of material/ equipment supplied by the bidder from the date of delivery.
