EMD: Rs. 10000/- shall be deposited and refunded as per NCDFI norms.

Technical Specifications:

- **Characteristics:** Non-Expandable / Non-Reversible
- **Dimension:** 1200 mm × 1000 mm × 120 mm (min)
- **Top & Bottom Surface:** Perforated
- **Colour:** Blue
- **Manufacturing Process:** Injection Moulding
- **Material of Construction:** 100% virgin grade HDPE / PP
- **Load Bearing Capacity:** Static → 2000 kg (min), Dynamic → 1000 kg

General Terms & Conditions:

1. Interested bidders are required to deposit the EMD to ensure participation in Reverse Auction.
2. Prior to Reverse Auction, the interested bidder must send a sample to the Milk Union at his own risk and cost wherein the Milk Union shall check the conformation to the technical specification. The bids of the bidders whose sample are compliant with the above specifications shall only be considered for evaluation. The sample may be preserved by the Milk Union for future references.
3. Details of Company and sample specification documents must accompany the sample.
4. **Rate** to be quoted by the bidder must include all taxes and levies, transportation, transit insurance, loading, unloading and other incidental charges if any for delivery of goods at the Milk Union.
5. **Supply of Goods:** The supply of goods must be completed within 30 days from the date of issue of Purchase Order.
6. **Place of Delivery:** The office of The Bhagirathi Cooperative Milk Producers' Union Ltd. Feeder Dairy, Panchantala, Berhampore, Murshidabad, Pin-742165, West Bengal.
7. Mode of transportation, transit insurance for the supply of the goods to the Milk Union must be arranged by the supplier.
8. Materials dispatched from the supplier until or unless it reaches the Milk Union is the sole responsibility of the supplier. The Milk Union will not be responsible for any damage in transit and no claim in this regard will be entertained.
9. No escalation of rate shall be entertained during execution of the Contract.
10. **Inspection of Goods:** The Quality Control department of the Milk Union shall conduct qualitative and quantitative inspections pertaining to the sample deposited, the required specification and the material supplied. If the supplied material does not conform to the approved sample and technical specification, the supplied material shall be rejected outright. Materials with dents, deformations in transit shall not be accepted. In case goods are rejected by the Milk Union the supplier may depute the Quality Control personnel of his company for mutual/joint inspection.
11. **Payment** shall be made within 30 days of acceptance of goods in NEFT/RTGS in the bank account of the supplier subject to submission of documents mentioned in the documentation clause of this NIT/NIRA. If the materials received do not conform to the above prescribed standard and sample approved by Milk Union, then the materials shall be rejected straightway. The supplier may depute his/her Quality Control personnel for Joint Inspection.

12. **Penal Measure:** Time being the essence of the contract, failure to supply the materials within due time or delay in installation and commissioning of the materials shall invite penalty.
- I. Liquidated damages of 0.5% per day, subject to a maximum of 10% of the total cost of materials, shall be charged if goods are not delivered on time and the amount will be deducted from the EMD and bills submitted by the supplier.
 - II. For violation of any terms and conditions of the contract the Bhagirathi Milk Union reserves the right to cancel the contract without assigning any reason thereof. On termination of Contract the Security Deposit will be forfeited and the resultant loss shall be recovered from the company. The subsequent company will be blacklisted for 3 years.
11. **Loading and unloading** of goods is the responsibility of the supplier. If the Milk Union makes arrangement for the unloading of the materials, the respective cost of the same shall be deducted from the bidder.
12. **Documentation:** Complete documentation like technical specifications, certificate of analysis, e-way bill, 3 copies of invoices must be furnished by the supplier. Failure to submit any of the above documents in hard copies at the time of supply of the materials shall lead to non-acceptance of the material.
13. **Packing:** The Supplier shall provide such packing of the Goods as is required to prevent their damage or deterioration during transit to their destination, as indicated in the Purchase Order.
14. **Dispute Resolution:** In case of any dispute between the party and the Milk Union, the decision of the Milk Union shall be final and binding.
15. **Applicable Law:** The Agreement shall be interpreted in accordance with the laws of Union of India.
16. **Force Majeure:** If, at any time during the subsistence of this contract, the performance in whole or in part by either party of any obligation under this contract is prevented or delayed by reasons of any war or hostility, act of public enemy, civil commotion, sabotage, fire, floods, explosion, epidemics, quarantine restriction, strikers lockout or act of God (hereinafter referred to as events) neither party shall have any claim for damages against other in respect of such non-performance or delay in performance.
17. The undersigned reserves the right to accept or reject any tenders and to cancel the entire tender process without assigning any reason whatsoever.
18. The order shall also take the General Terms and Conditions stipulated by NCDFI in the Reverse Auction Notice referred above.
