**Scope of Work:** Supply of Caustic Soda Lye (Sodium Hydroxide Solution 45-50%) as per IS 252:1991 & IS 252:2013

**Quantity Required:** 10,000 kgs.

**Bid Validity:** 60 days

**Tentative Delivery/Supply Schedule:** Within 15 days of placement of Purchase/Supply Order.

**Technical Specification:** Sodium Hydroxide Solution as per IS 252:1991 & 252:2013

**General Terms and Condition**

- Rate to be quoted by the Bidder:** Rate to be quoted by the bidder shall be inclusive of all taxes, levies, GST, incidental charges if any, for the delivery of the materials in the Store Office of The Bhagirathi Cooperative Milk Producers' Union Ltd.
- Place of Delivery:** In the Store Office of the Bhagirathi Co-operative Milk Producers' Union (BCMPUL) Feeder Dairy, Panchanantala, Berhampore, Murshidabad, W.B. 742101.
- Price Escalation:** The price quoted shall be fixed till bid validity period. Any claim for escalation of price during the bid validity period or contract quantity shall not be entertained.
- Certificates:**
  - Manufacturer's / Supplier's Certificate of Analysis.
  - Test report from manufacturer.
  - Food Grade Certificate.
- Packing:** Should be packed in HDPE Jars/Carboys of 50 Kgs or Steel Drums of 50 Kgs.
- Markings:** The containers shall bear legibly and indelibly the following information:
  - BIS Standard Mark.
  - Name & Grade of material.
  - Indication of Source of Manufacture.
  - Net Mass of material.
  - Batch Number/Lot Number/Code/Otherwise.
- Payment Terms:** Payment shall be released in NEFT/RTGS to the Bank Account of the supplier within 45 days after acceptance of goods and after submission of 3 copies of invoice along with documents mentioned in documentation clause 4.

8. **Mode of Transport & Transit Insurance:** Mode of transportation and transit insurance for the supply of the goods will be arranged by the supplier.
9. **Unloading of Material:** Unloading of goods shall be the sole responsibility of the supplier. If the Milk Union makes unloading arrangements on behalf of the supplier, the cost of unloading shall be deducted from the bills of the supplier. The unloading shall be done within office hours. (10:00 am to 06:00 pm).
10. **Acceptance of Material:** Quantitative Test and Qualitative tests may be carried out as per BIS norms prior to acceptance of material. Material must be suitably packed and transported to reach the destination in good condition. Spilled containers shall not be accepted. Material supplied should meet the technical specifications as enshrined in this document. Materials not adhering to specifications shall be rejected. Upon rejection the material must be lifted by the supplier from the warehouse of the Milk Union within 30 days, failing to which the Milk Union shall dispose of the material and no claim in this regard shall be entertained.
11. **Liquidated Damage:** If materials are not delivered in due time as enshrined in the Purchase/Supply Order, the Milk Union reserves the right to impose a penalty Rs. 500/- per day subject to a maximum of 10% of the total cost and the damage shall be recovered from the EMD and bills of the supplier.
12. **Cancellation of Contract:** If the materials are not delivered in a reasonable time, then the Milk Union reserves the right to cancel the Contract/Order. Upon cancellation of the Order the bidder shall be blacklisted by the Milk Union.
13. **Force Majeure:** If, at any time during the subsistence of this contract, the performance in whole or in part by either party of any obligation under this contract is prevented or delayed by reasons of any war or hostility, act of public enemy, civil commotion, sabotage, fire, floods, explosion, epidemics, quarantine restriction, strikers lockout or act of God (hereinafter referred to as events) neither party shall have any claim for damages against other in respect of such non-performance or delay in performance.
14. **Dispute Settlement:** In Case of any dispute between the Supplier and Milk Union, decision of the Milk Union shall be the final and binding.
15. The Milk Union may accept or reject any bids or cancel the entire tender/Reverse Auction at any point of time without assigning any reason thereof.
16. This tender shall take the standard terms and conditions as stipulated by NCDFI.
