GENERAL TERMS AND CONDITIONS:

- 1. Any conditional or incomplete Quotation shall not be accepted.
- 2. The successful Quotation must commission the work within a period of 7 days from the date of issue of Work order.
- 3. The rate quoted is inclusive of all labor and material required for the Job. The Tender involves scope of supply and service.
- 4. No escalation in price / rate will be allowed on any ground and no claim in this regard shall be entertained.
- 5. No mobilization advance shall be given for this contract at any cost.
- 6. All the rates quoted by the Tender must be inclusive of all required materials in adherence to schedule of job as furnished in the Quotation.
- 7. Terms of Payment: The payment shall be released in two phases:
 - a. Payment made within 15 days after successfully completion of the work
 - b. For non GST registered agency / Firm/ Person or Proprietor GST will be paid by the milk Union Additionally.
- 8. Payment will only be made in NEFT/RTGS after Approval from Competent Authority. Three copies of invoices must be submitted for payment.
- 9. Liquated damage: Liquidated damage of minimum 0.5% per day of the total Order awarded to the bidder shall be charged if there is any delay in completion or inception of the job subjected to a maximum of 10% and the cost shall be recovered from the Contractor by deducting from the bills.
- 10. If the tender has already been blacklisted by any Government/ Government Undertakings/ Cooperative societies, his tender will be rejected. In case information about such black listing comes to the knowledge of the Union after awarding of the tender, the contract will be terminated, liquidated damages levied, apart from taking penal action.
- 11. BCMPUL reserves the right to accept or reject any or all tender wholly / partly at any point of time without assigning any reason thereof.

- 12. Force Majeure: For any delay in job not attributable to the Contractor and the Milk Union shall be termed as Liquated damage such as war, lockouts, catastrophe or any act of God. No liquidated damage on account of the Contractor shall be deducted for this clause.
- 13. Successful bidder has to complete the work within 7 days
- 14. For any disputes beaten the Milk Union and Contractor the decision of the Milk Union shall be the final binding.

Precautions:

- 1. The Quotation must perform site inspection and the requirement of the Union before submitting his tender.
- 2. The person signing the tender should be the Proprietor / Partner / Managing Director or any other person duly authorized to sign the tender document. In the latter case, authorization letter should be attached.
